Kestrel Haven is a pro bono private research facility and sanctuary in Burdett, NY that was established by Dr. John and Sue Gregoire in 1986. The Gregoire's have accomplished all of the field work in Queen Catharine Marsh and other areas of Schuyler County to allow for the county comprehensive plan environmental areas, the Important Bird Area, Bird Conservation Area and Critical Environmental Area designations within the county, as well as assisting the National Forest Service and the DEC in Schuyler field biology projects. Their sanctuary will be an asset in the county forever as it is perpetually protected through a conservation easement with the Humane Society Wildlife Land Trust. That easement was the first of its kind in Schuyler. It is not open to the public and reserved for the exclusive benefit of wildlife.

The Finger Lakes National Forest encompasses over 16,212 acres nestled between Seneca and Cayuga Lakes. The Forest has over 30 miles of interconnecting trails that traverse gorges, ravines, pastures, and woodlands. Since 1996 the Forest also protects the site of a historic summer camp along Seneca Lake with connections to the Women's Rights Movement. The headwaters of many streams leading into Seneca Lake from its' eastern slope originate in the Finger Lakes National Forest.

Solar Seneca is a community based group which plans to bring residents and businesses together with solar power installers. We are also interested in exploring the possibilities of solar installations on schools and other municipal buildings. We are currently awaiting a decision by NYSERDA on our community solar grant application to begin our efforts. Over the past four months, we have been discussing bringing more solar power to the southern four towns of Seneca County: Covert, Lodi, Ovid & Romulus. Besides a description of what kinds of solar power systems we are considering, we will be seeking one representative from the four towns and several others to form a board of directors for Solar Seneca. Another goal includes reproducing the Solar Tompkins program, though on a smaller scale since Seneca County has one third the population of Tompkins County. If our initiative in the southern four towns is successful, we will attempt to create a Seneca County wide program. At this time, we have not vetted or contracted with any solar contractors. Should our grant be approved, we will send out a Request for Proposals (RfP) and meet with solar contractors interested in working with us.

Gas Free Seneca was formed in early 2011 in response to Texas-based Crestwood's plan to "build an integrated gas storage and transportation hub for the Northeast," on the shores of Seneca Lake, at the U.S. Salt plant property. The project involves storing gas in unlined, unstable depleted salt caverns that were not engineered for storage, where the company states it has "over 40 million barrels of energy storage capacity". Concerns include: cavern instability, massive industrialization of a world-class wine and tourist region and the negative economic impact that would have in exchange for 10 gas industry jobs, trucks, trains, lights, and noise, along with the threat of catastrophic accidents from storing and transporting dangerous hazardous material in the area, and the threat of increased salinization of Seneca Lake, a drinking water source for 100,000 people. This has resulted in an Issues Conference with the DEC which may lead to a full adjudicatory hearing. Gas Free Seneca started out as a small group of concerned citizens trying to spread the word about the proposed LPG storage facility. Since its inception, Gas Free Seneca has grown into a coalition of thousands of concerned citizens throughout the Finger Lakes region, over 300 regional business owners, and 17 municipalities representing half a million people around the lake who have drafted resolutions against this ill-conceived plan. It is the aim of Gas Free Seneca to protect Seneca Lake, its environs and local home-grown businesses from this threat.

Between Seneca Lake and Cayuga Lake, the two largest of the Finger Lakes is an area of 20,000 to 25,000 acres that comprises a rural farming community that existed from the time of settlement in the late 1700s and early 1800s. Much of it was acquired by the federal government under the authority of the Resettlement Administration, a program of the New Deal in the 1930s. Since acquisition by the Federal Government, the publicly owned lands have been managed under several different federal jurisdictions. About two-thirds of the area is currently the Finger Lakes National Forest, while the remaining area is in private ownership. In the 1930s and 1940s, the land was cleared of buildings although foundations of houses, barns, schools, mills and other features including family burial plots still exist. Those lands considered of sub-marginal quality for cropping were reforested. Other better quality lands were set aside for a cooperative grazing program which continues today.

The Backbone Ridge History Group has for the past seven years and will continue to collect, preserve, interpret and share with the public the historical aspects of life on and around the Backbone Ridge through a research center containing oral histories and documents, a semi-annual cemetery restoration, public programming and publications including a quarterly newsletter for the membership. A long term goal is a living history interpretive site somewhere on the Backbone Ridge that will reflect the time between the population peak in 1850 and when the families were removed by the federal government in the 1930s and 1940s.

Seneca Lake Pure Waters Association (SLPWA) is committed to the preservation and improvement of the lake water quality and its environs. SLPWA studies issues that are likely to impact the lake in adverse ways and works with the watershed communities to educate the public and collaborate with organizations that have similar goals. Over the past 6 years, SLPWA has been actively involved in critiquing the proposal to exploit shale gas from the region by high volume hydraulic fracturing (HVHF) and provided extensive input to the Governor and DEC opposing the use of this technology in New York State. SLPWA recently participated in the DEC Issues Conference in order to qualify for “party status” in future adjudicatory hearings on the ill-advised liquefied petroleum gas (LPG) storage in abandoned salt mines next to the lake. SLPWA is also collaborating with Community Science Institute, Ithaca, NY (<http://communityscience.org/>) to do extensive stream monitoring and analysis to determine the sources of lake pollution and to find ways to remediate it. SLPWA has over 400 members and is working to expand its membership and volunteers to carry out this important work.
